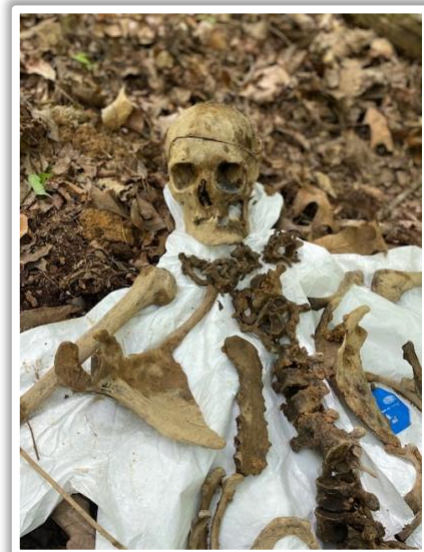
Death Investigations 80-hour certification course

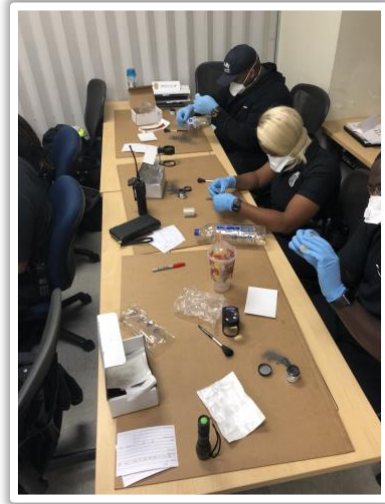


Crime Scene Identification

The Homicide Investigation

The Investigators will cover the procedures, follow ups and structure of the homicide investigation as a team and individual investigator duties working with crime scene investigators, and the case preparation with prosecutor, the investigators will be taught techniques on interviews and interrogations of witnesses and offenders. Investigator will study and analyze homicide case studies.



Fingerprint processing

Medical Postmortem Examination

Investigators will work with medical examiners and learn to identify cases of natural deaths, suicides, accidental death, unlawful death investigation, gunshot wounds, knife wounds, blunt force trauma, tool mark impressions, body fingerprint processing, time of death identification and procedures for collection of evidence at the medical examiner's office.

Legal

Investigators will have a clear understanding of the case preparation and court presentation of their homicide investigation. They will understand all laws and legal procedures necessary for taking a homicide investigation into the legal arena. Investigators will work with prosecutors on arrest warrants and search warrants, prefile conferences, depositions, suppression hearings and preparation for trial, as well as learn techniques to testifying in court, and all the procedures for a successful prosecuting and conviction of their case.
